

THE CORPORATION OF THE CITY OF TEMISKAMING SHORES
BY-LAW NO. 2004-008
BEING A BY-LAW TO APPOINT VARIOUS COMMITTEES,
BOARDS AND REPRESENTATIVES FOR 2004, 2005 AND 2006.

WHEREAS under Section 8 of the Municipal Act, 2001, S.O., 2001, c.25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS under Section 9. (1) (a) and (b) of the Municipal Act, 2001, S.O., 2001, c.25, as amended, Section 8 shall be interpreted broadly so as to confer broad authority on municipalities to enable them to govern their affairs as they consider appropriate and to enhance their ability to respond to municipal issues;

AND WHEREAS in accordance with Section 130 of the Municipal Act, S.O. 2001, c.25, as amended, council may regulate matters not specifically provided for by this Act or any other Act for purposes related to the health, safety and well-being of the inhabitants of the municipality;

AND WHEREAS the Council of The Corporation of the City of Temiskaming Shores deems it expedient to appoint various committees, board and representatives for 2004, 2005 and 2006.

NOW THEREFORE the Council of The Corporation of the City of Temiskaming Shores hereby enacts as follows:

- i) That the members appointed to various committees and boards are listed on Schedule "A", hereto attached and forming part of this by-law.
